WITNESSETH:

WHEREAS, Declarant desires to amend said declaration; and

WHEREAS, Declarant, pursuant to 47C-2-105(a)(8) of the North Carolina Condominium Act and the rights reserved in the Declaration of Condominium For Bradford Place Condominiums at Downing Creek, does hereby amend the Declaration:

ARTICLE I




